1) Legislation Title: *Apply for permits to allow for installation of a renewable energy project developed by Lucid Energy, Inc. and the Portland Water Bureau (Ordinance)

2) Purpose of the Proposed Legislation: The purpose of this ordinance is to authorize the Portland Water Bureau (PWB) on behalf of the City of Portland and in cooperation with Lucid Energy, Inc. (LEI), to complete and submit an application to the Oregon Water Resources Department (OWRD) and the Federal Energy Regulatory Commission (FERC) for the required permits and license exemptions to allow for installation of this renewable energy project.

In a Memorandum of Understanding between the City of Portland (City), PWB, Portland Development Commission and LEI, the parties recognized Portland's status as a global leader in clean energy and viewed their prospective partnership as an opportunity to leverage Portland's leadership in clean and green innovation and extend Portland's expertise in environmental technologies and advanced manufacturing, thereby addressing goals of the City's economic development strategy.

PWB and LEI have signed a Final Term Sheet which describes an anticipated agreement to allow LEI access to PWB facilities to generate renewable electricity. PWB will earn a financial benefit by sharing in the proceeds from the energy production that result from the project. In addition, PWB will learn more about the feasibility of power production within its system.
