

ORDINANCE No. **185818**

* Amend contract with Portillo Consulting International to provide additional funds for Police Review Board Facilitation for the Portland Police Bureau (Ordinance; amend Contract No. 30001583)

The City of Portland ordains:

Section 1. The Council finds:

1. The Police Bureau finds value in having outside facilitation of Police Review Board meetings.
2. Portillo Consulting International has provided these services to the bureau through a contract awarded through a competitive bidding process since 2010.
3. Contract No. 30001583 with Portillo Consulting International was executed in August 2010 for a term of three years expiring August 31, 2013 if not extended for additional time. The compensation to the contractor was limited to \$33,333 during the three year term of the contract.
4. Amendment No. 1 to the contract added two additional Review Board note takers at a rate of \$75 per hour.
5. Amendment No. 2 to the contract added an additional Review Board note taker at a rate of \$75 per hour.
6. Amendment No. 3 to the contract added an additional \$8,299 of compensation to the contract for Review Board Facilitation services.
7. Amendment No. 4 would add an additional \$16,000 to pay for Police Review Board facilitation through the term of the contract.

NOW, THEREFORE, the Council directs:

- a. The Mayor and City Auditor are hereby authorized to execute Amendment No. 4 to Contract No. 30001583 between the City of Portland and Portillo Consulting International in a form substantially in accordance with the attached Exhibit A.

Section 2. The Council declares an emergency exists because delay in proceeding with this amendment will unnecessarily delay the payment due for services provided under the existing contract. Therefore, this ordinance shall be in full force and effect from and after its passage by City Council.


