ORDINANCE No. 185856

* Ratify Letters of Agreement between the City and the City of Portland Professional Employees Association; the Portland Police Commanding Officers Association; Laborers', Local 483; the American Federation of State, County and Municipal Employees, Local 189-2; and the member unions of the District Council of Trade Unions authorizing two additional representatives to the Labor Management Benefits Committee (Ordinance)

The City of Portland ordains:

Section 1. The Council finds:

1. The City and the American Federation of State, County and Municipal Employees, Local 189-3 (AFSCME, Local 189-3) are parties to a Collective Bargaining Agreement (the Housing CBA), the term of which is July 1, 2011 to June 30, 2015.
2. Article 14.1 of the Housing CBA provides for adding one AFSCME, Local 189-3 bargaining unit representative and one additional City representative to the Labor Management Benefits Committee (LMBC).
3. The City has entered into a Letter of Agreement (LOA) with five of the six labor organizations that participate in the LMBC that amends each labor agreement by adding one AFSCME, Local 189-3 bargaining unit representative and one additional City representative to the LMBC. The participating labor organizations include the City of Portland Professional Employees Association (COPPEA); the Portland Police Commanding Officers Association (PPCOA); Laborers' Local 483 (Recreation); the American Federation of State, County and Municipal Employees, Local 189-2 (BOEC); and the member unions of the District Council of Trade Unions (DCTU).
4. Although the Portland Fire Fighters Association (PFFA) is also a member labor organization of the LMBC, the City did not enter into an LOA with PFFA because the addition of one City representative and one AFSCME, Local 189-3 representative was included in the PFFA labor agreement for July 1, 2012 to June 30, 2016.

NOW, THEREFORE, the Council directs:

- a. The LOAs between the City and COPPEA, PPCOA, Recreation, BOEC and the DCTU attached as Exhibit A are hereby ratified by the Council.


Section 2. The Council declares that an emergency exists in order that this action may occur without delay; therefore, this ordinance shall be in full force and effect from and after its passage by the Council.
