1) Legislation Title:

Authorize Intergovernmental Agreement with Portland State University to prepare population, housing unit, and household estimates and forecasts (Ordinance)

2) Purpose of the Proposed Legislation:

The Regional Water Providers Consortium (Consortium) serves as a collaborative and coordinating organization to improve the planning and management of municipal water supplies in the region. Portland is a member of the Consortium and also collects and manages the funds of the Consortium under Intergovernmental Agreement No. 50880. Portland State University's Population Research Center (PRC) is an interdisciplinary public service, research and training unit for population-related data and research for the State of Oregon. The PRC provides population data, information, and research analysis for Oregon and its communities and has access to the data and expertise to conduct this work.

Consortium members have an on-going need for estimates and forecasts of total population and number of housing units and households within their service areas and require the PRC to provide this information. The data will help determine future water demand and also measure per capita demand. The data is used in the preparation of water master plans, state mandated water management and conservation plans, and other related documents. While many water providers obtain this information periodically on an individual basis, having all of the estimates and forecasts done at the same time with the same data set and methodology will enable the water providers to have more consistent and accurate information while achieving economies of scale.
