Section 1. The Council finds:

- 1. The Bureau of Environmental Services (BES) has need of continuing professional engineering services provided by Brown and Caldwell, Inc. (B&C) for required Fanno Creek Basin Sewer System Improvements.
- 2. B&C is continuing to provide professional engineering services under Contract No. 30002215 effective August 1, 2011 with an expiration date of July 31, 2016.
- 3. The estimated cost of this contract amendment is \$359,811. Funds are available in the Sewer System Operating Fund, FY 2013 Budget, and BES Project No. E09051. The level of confidence in the negotiated cost for the proposed amendment 3 to contract No. 30002215 with B&C is high.
- 4. M/W/ESB participation after the authorization of contract amendment 3 will be \$1,076,737, 36.7% of the amended contract amount of \$2,931,546.

NOW, THEREFORE, the Council directs:

- a. The Commissioner in charge is authorized to execute amendment 3 to contract 30002215 with Brown and Caldwell, Inc. for the purpose described in Section 1.
- b. The Mayor and Auditor are hereby authorized to draw and deliver warrants chargeable to the Sewer System Operating Fund Budget when demand is presented and approved by the proper authority.
