9. BACKGROUND/ANALYSIS

The Police Bureau is undertaking efforts targeted to strengthen initiatives already underway to ensure that encounters between police and persons with perceived or actual mental illness, or experiencing a mental health crisis, do not result in unnecessary or excessive use of force. The ability of police officers to protect themselves and the community they serve is largely dependent on the quality of the relationship they have with that community. Public and officer safety, constitutional policing, and the community's trust and confidence in its police force are, thus, interdependent.

A baseline level of public trust and confidence in the Police Bureau must be established in order to determine whether community engagement and changes in police policy and procedure lead to improvement or erosion in that public trust. Portland State University has helped the bureau collect and analyze similar data in the past and is well-suited to provide these services for this purpose.

Adequate one-time General Fund appropriations for the Police Bureau to use for this specific item were authorized by City Council in the FY 2012-13 Winter Budget Monitoring Process.
