The City of Portland, Oregon Police Bureau wishes to apply for USDOJ OJP BJA FY 2013 BVP grant funding. The USDOJ may reimburse the City for expenses incurred for the purchase of 30 Threat Level III-A bulletproof vests for Police Bureau sworn personnel with the rank of officer through lieutenant (per Bureau Directive 1110.00 - Body Armor) whose vests are due for replacement during the next five years. The award amount will be based on the overall number of grant requests received by USDOJ.



8. BACKGROUND/ANALYSIS

The City of Portland, Oregon Police Bureau wishes to apply for USDOJ OJP BJA FY 2013 BVP grant funding. The Bulletproof Vest Partnership (BVP), created by the Bulletproof Vest Partnership Grant Act of 1998, is a unique U.S. Department of Justice initiative designed to provide a critical resource to state and local law enforcement. Since 1999, over 13,000 jurisdictions have participated in the BVP Program, with \$277 million in federal funds committed to support the purchase of an estimated 800,000 vests.

The U.S. Department of Justice (USDOJ), Office of Justice Programs (OJP), Bureau of Justice Assistance (BJA) may provide grant funding for the purchase of National Institute of Justice (NIJ) compliant bulletproof vests for local law enforcement agencies. The grant application must be submitted prior to May 20, 2013.

There are no legal or controversial issues with this grant application. There is no citizen participation, no links to current City policies and no other governmental participation with this grant application.
