

# ORDINANCE NO. 186037

Authorize an Intergovernmental Agreement with the City of Sandy to Design and Construct Fiber Optic Improvements (Ordinance)

The City of Portland ordains:

Section 1. The Council finds:

1. In 2012, the Water Bureau and Portland General Electric entered into an agreement to exchange dark fiber capacity over separately owned and operated fiber optic communication systems. The exchange agreement addresses the exchange and use of dark fiber, handholes, vaults and access points between and among Portland General Electric and the Water Bureau.
2. This project will provide a backup connection between Headworks, Lusted Hill and Interstate and will provide capacity for future supervisory control and data acquisition (SCADA) upgrades at Headworks that exceed the capacity of the existing microwave system.
3. This project supports the Dark Fiber Lease Agreement signed in March 2012 between the Water Bureau and Portland General Electric. It will provide a buried fiber link between the PWB facilities at Headworks and Lusted Hill with the Clackamas County Fiber Ring.
4. The City of Sandy is undertaking to build a system of conduit and optical fibers, and will include separate, additional facilities for the Water Bureau. As part of this project, the City of Sandy will design and construct additional fiber infrastructure within the right-of-way of SE Bluff Road from approximately SE Dunn Road to SE Bell Road and within SE Bell Road from SE Bluff Road to Sandy High School.
5. This Intergovernmental Agreement is for the design and construction of the fiber optic infrastructure by the City of Sandy for the PWB and will include assets that will be turned over to the Water Bureau.
6. The Water Bureau will reimburse the City of Sandy for PWB's portion of those assets constructed. The value of this agreement shall not exceed \$65,000. Funding for the agreement is available in the FY 2012-13 Budget in the treatment program as part of the Headworks Flow Meters Project and has been requested in the FY 2013-14 Budget. The proposed action will not result in a change to the forecast water rates and the project currently has a high level of confidence.

NOW, THEREFORE, the Council directs:

- a. The Water Bureau Administrator is authorized to execute on behalf of the City an Intergovernmental Agreement with the City of Sandy to design and construct fiber optic improvements in a form in accordance with the Intergovernmental Agreement attached as Exhibit A.

- b. The Mayor and Auditor are hereby authorized to draw and deliver checks chargeable to the Water Fund when demand is presented and approved by the proper authorities, for the Intergovernmental Agreement.
- c. Amendments increasing the total compensation of the Intergovernmental Agreement may be agreed to and executed by the Water Bureau Administrator up to twenty-five percent of the total agreement amount. Any increase exceeding twenty-five percent of the total compensation would need City Council approval.
