The \$15,000 designated for Hacienda CDC is a portion of two grants totaling \$50,000 to integrate equity into the update of the Climate Action Plan and develop climate equity metrics to measure progress. The City is passing-through the funding from the Bullitt Foundation to Hacienda CDC. Because Hacienda CDC is directly managing this portion of the grant project, the City is not involved with public involvement.
However, BPS directly manages the work related to the remaining grant funds (\$30,000) for which there has been public involvement. 5. Purpose of Agenda Item:

This Ordinance will authorize a Grant Agreement between the City and Hacienda CDC. The City will provide Hacienda CDC with \$15,000, in pass-through resources from the Bullitt Foundation to develop an implementation plan to achieve equity and carbon emission reduction outcomes in an underserved neighborhood while supporting the Climate Action Plan and Portland Plan. The Emergency exists so that the City and Hacienda can meet the timelines in the grant award from the Bullitt Foundation; therefore this ordinance shall be in full force and effect from and after its passage by the Council.

6. History of Agenda Item/Background:

On March 13, 2013, by Ordinance 185919, City Council authorized acceptance of \$25,000 in funds from the Bullitt Foundation to integrate social equity metrics and outcomes into the Climate Action Plan. The Bullitt Foundation's grant designated \$15,000 to be distributed to Hacienda CDC, a nonprofit that works to strengthen families in underserved neighborhoods and at low income properties. Hacienda CDC will develop a detailed implementation plan for achieving these goals within Villa de Clara Vista, a multi-family low income rental property owned by Hacienda CDC that is scheduled to undergo a major renovation. The Bureau of Planning and Sustainability is using the remaining \$10,000 of the grant funds from the Bullitt Foundation to integrate equity into the update of the Climate Action Plan that is currently underway.



8. What individuals or groups are or would be supportive or opposed to this action? Opposition: None.

Supportive: Organizations working to advance social equity; the community of Villa de Clara Vista.

9. How does this relate to current City policies?

This work supports the Climate Action Plan and promotes equity and a prosperous, educated healthy city which is identified as a core priority within the Portland Plan. Additionally, this project supports the work of the Bureau of Planning and Sustainability and the Office of Equity and Human Rights to recognize and remove systemic social equity barriers.
