7. BACKGROUND/ANALYSIS

Orange Splot LLC is a builder / developer of community-oriented housing, whose current project, Cully Grove, is a 16 home development at 4745 NE Going Street. The housing units are single family detached residences, duplexes and triplexes. Orange Splot alleges actions by BDS resulted in unnecessary additional costs related to electrical work performed under the building permits for this project. Specifically, BDS inspectors noted electric meters were grouped at the end of each of the three triplex buildings, and multiple service lines ran through attic spaces above individual townhomes. This installation was reviewed by senior inspectors and found to be not compliant with the state codes for townhome construction. Nonetheless, the inspectors allowed the installation to remain, given that significant additional construction work had already occurred. Approximately two months later, the BDS Inspection Supervisor overruled this decision, and Orange Splot was advised the electrical services would need to be removed and rerouted to meet the code requirement.

BDS acknowledges the initial approval granted in October 2012 was in error, and the builder should have been told to reinstall the electrical feeder lines at that time.

8. FINANCIAL IMPACT

Approval of the settlement would result in total payments of \$11,002 from the liability fund. Total settlement amount is \$11,002, less \$5,000 previously advanced by Risk Management.

9. RECOMMENDATION/ACTION REQUESTED

Approve settlement of Orange Splot, LLC property damage claim in the sum of \$11,002.
