These funds are provided for the development of an all hazard emergency management capability to promote planning, response, exercise, training and community outreach. Grant funds are budgeted for one half of the cost of three Portland Bureau of Emergency Management (PBEM) positions, one half of the annual rent for PBEM office space, one half the cost of a Hazard Mitigation Plan Update consultant and one half of Emergency Coordination Center information technology operational support. All funds received through the EMPG program will be provided on a reimbursable basis and will be matched 50% in the form of salary, benefits, and materials and services in the FY 2013-14 budget of the Portland Bureau of Emergency Management.
