This is an amendment to City of Portland Contract No. 30002306, between the City of Portland, Oregon Police Bureau Detectives Division, hereinafter referred to as PPB DETECTIVES, and on behalf of Multnomah County, Oregon Office of the District Attorney, hereinafter referred to as MC. This amendment is effective October 1, 2012, or the date on which each party has signed this amendment, whichever is later.

The parties agree:

- 1. The following changes are made to Contract No. 30002306;
 - a. The Contract is modified to extend the term from March 31, 2013, to December 31, 2013;
 - b. Additional compensation is necessary and shall not exceed \$5,416; and
 - c. The parties agree the PPB Detectives and MC may conduct this transaction by electronic means, including the use of electronic signatures.
- 2. Prior to this amendment the Agreement value was \$89,913 in U.S. Department of Justice (USDOJ), Office of Justice Programs (OJP), Bureau of Justice Assistance (BJA) grant funding. After this amendment the value of the Agreement is \$95,329 in USDOJ OJP BJA grant funding.
- 3. All other terms and conditions of the agreement shall remain the same.
