- 9) If "YES," please answer the following questions:
 - a) What impacts are anticipated in the community from this proposed Council item?

This contract will start the design process and the community involvement process including the advisory committee. Private property owners near the culvert are concerned about impacts to private property and are engaged in the process. Construction impacts will include traffic delays and possible detours.

b) Which community and business groups, under-represented groups, organizations, external government entities, and other interested parties were involved in this effort, and when and how were they involved?

From 2001 through 2006, citizens and agency representatives served on the Fanno and Tryon Creeks Watershed Management Plan 2005 (Plan) Advisory Committee. Committee members met monthly from June 25, 2001 through January 2006 and represented Clean Water Services, Oregon State Parks, City of Lake Oswego, Hayhurst Neighborhood Association, Tryon Creek Watershed Council, Bridlemile Neighborhood Association, Marshall Park Neighborhood Association, a private business and other City bureaus. The Plan identified the Boones Ferry Road Culvert as an action item and was presented at a series of open houses and media.

From April 2006 through June 2008, this project and others were further developed through the Fanno/Tryon Water Quality and TMDL CIP Pre-design. That process included an advisory committee made up of representatives from the Oregon Department of Environmental Quality, Oregon State Parks, Oregon Department of Transportation, Clean Water Services, Bridlemile Creek Stewards, City of Lake Oswego, Friends of Tryon Creek State Park and the Tryon Creek Watershed Council. The culvert replacement project and others were presented to the public at a series of open houses, meetings and media.

When the pre-design report was released, this project created keen public interest from the pedestrian community. Since the culvert aligns with SW Trails #6 (Hillsdale to Lake Oswego) several organizations were interested to also include pedestrian passage through the new culvert. Currently, the culvert is a barrier not just to fish, but to pedestrians, making walkers leave a trail along Tryon Creek to cross SW Boones Ferry at blind, high speed curve. Portland Bureau of Transportation, Oregon State Parks and Metro are all supportive of including a pedestrian underpass as part of this project. In 2007, the community contacted Com Adams' Office about this project which led to a multi bureau meeting in April 2008 to discuss the project.

Further interest in this project is from the fish passage perspective. The Tryon Creek Watershed Council has been partnering for many years with US Fish and Wildlife, Oregon Department of Fish and Wildlife, citizens and BES to monitor and make improvements for fish throughout the system.

- c) How did public involvement shape the outcome of this Council item?

 Community prioritization of this project moved it forward to the BES CIP list. Pedestrian interests added the determination of feasibility and cost of a pedestrian underpass to the design contract.

10) Is any future public involvement anticipated or necessary for this Council item? Please describe why or why not.

Because of the pedestrian element, this project will have an advisory committee, hosted by SW Neighborhoods Inc, to provide feedback to engineering plans. Parties interested in committee membership are: private property owners adjacent to the culvert, transportation chairs of local neighborhood associations, Oregon State Parks, SW Trails Pdx, SWNI Transportation Committee, Friends of Tryon Creek State Park, PBOT and Metro. Presentations to this committee and incorporating feedback are included in the scope of the engineering contract.
