

**ORDINANCE No. 186332**

Revise Ordinance for a contract with Cascadia Behavioral Healthcare, Inc. to correct contract amount and include sole source language (Ordinance; amend Ordinance No. 186088)

The City of Portland ordains:

Section 1. The Council finds:

1. Ordinance No. 186088 passed Council on June 12, 2013 authorizing a contract with Cascadia Behavioral Healthcare, Inc. to provide mental health services through Project Respond.
2. Ordinance No. 186088 included an error in the not to exceed amount of the contract.
3. The corrected Finding 5 of the ordinance should read as follows: The value of the contract is a not to exceed amount of \$265,526.
4. The ordinance lacked the necessary sole source language.
5. The ordinance should read: This sole source contract is being acquired as an exception to the competitive process identified in PCC 5.68 and the PTE Services Contracting Manual.

NOW, THEREFORE, The Council directs that:

- a. Ordinance No. 186088, Section 1.5 of the Council findings is amended to read as follows: The value of this contract would be a not to exceed amount of \$265,526.
- b. Ordinance No. 186088 is amended to include sole source language.
- c. All other terms and provisions of Ordinance No. 186088 remain the same and are not affected by this amendment.
