

ORDINANCE No. 186484

Authorize an Intergovernmental Agreement with Portland State University to accept \$75,180 to support an EcoPartnership with Kunming, China to advance low-carbon development. (Ordinance)

The City of Portland ordains:

Section 1. The Council finds

1. Portland entered in a non-binding EcoPartnership with the City of Kunming, China in May 2012. EcoPartnerships are formal agreements recognized by the U.S. State Department and China National Development and Reform Commission to facilitate sub-national collaborations on environmental issues.
2. Portland Mayor Charlie Hales and Kunming Mayor Li Wenrong affirmed the EcoPartnership in writing in January 2013 and in person in Kunming on October 31, 2013.
3. Portland State University has provided training for Chinese officials in urban planning through the PSU-China Innovations in Urbanization Program, a collaborative effort between the Hatfield School of Government and the Toulon School of Urban Studies and Planning, and officials from Kunming have participated in previous exchanges with Portland.
4. Portland State University and the City are committed to working together to share Portland's experience with planning and sustainable development, creating opportunities for Portland State University students and faculty, and bringing innovative ideas from around the world to Portland to inform City policy and programs.
5. The Energy Foundation has provided a grant to Portland State University to facilitate the exchange of technical expertise between Portland and Kunming to carry out the EcoPartnership and accelerate the transition to low-carbon development.
6. The funding agreement requires no City match.

NOW THEREFORE, The Council directs:

- a. The Mayor is hereby authorized to enter into an Intergovernmental Agreement with Portland State University on behalf of the City of Portland to accept \$75,180, and to execute a grant contract in substantially in the form of the attached Exhibit 1, "Portland State University Intergovernmental Subcontract Agreement No. 203FLY409," which by this reference is made part of this Ordinance.

- b. The City Fiscal Year FY 13-14 budget is amended.

- c. The Director of the Bureau of Planning and Sustainability of the City of Portland is authorized to accept on behalf of the City of Portland any subsequent modifications by Portland State University Agreement No. 203FLY409, provided such modifications do not increase the City of Portland's financial obligation or risk. Any modifications that increase the City of Portland's financial obligation or risk must be authorized by the Portland City Council.


