- 7. <u>BACKGROUND/ANALYSIS</u>: The Mt. Hood Cable Regulatory Commission collects PEG/I-Net fees under the cable services franchise agreements, funds capital costs of local governments and educational institutional use of the I-Net. The City of Portland, Bureau of Technology Services, who maintains the I-Net, is provisioning 2 Gigabit I-Net connections for
- the Portland Public Schools and the Multnomah Educational District. This requires the purchase of network equipment. For funding purposes the MHCRC is requiring an IGA to be established as a means for reimbursing the City for these installations.
- 8. <u>FINANCIAL IMPACT</u>: The purpose of the Ordinance is to authorize funding and therefore reimbursement from the MHCRC to the City of Portland in the amount of not to exceed \$50,000.00.
- **9.** <u>RECOMMENDATION/ACTION REQUESTED</u>: Authorize the Intergovernmental Agreement between the Mt Hood Regulatory Commission and the City of Portland, Bureau of Technology Services.
