ORDINANCE No. 186729 As Amended

Amend Disaster Policy Council membership and leadership strategy (Ordinance; amend Code Section 3.125.030)

The City of Portland Ordains:

Section 1. The Council finds:

- 1. The purpose of the Disaster Policy Council is to promote inter-bureau cooperation in furtherance of the City's integrated emergency management goals.
- 2. As disaster preparedness plans have developed over time, the need for participation by additional City bureaus is essential to a coordinated response.
- 3. Planning for Disaster Policy Council leadership strategy is critical to the public's safety in an emergency.

NOW, THEREFORE, the Council directs:

a. Section 3.125.030 is amended as follows:

3.125.030 Membership.

The DPC shall consist of the following members:

- A. The Mayor, who shall be Chair;
- **B.** Commissioner serving as President of the City Council, who shall be Vice Chair;
- C. If the Mayor or the President of the Council is not the Commissioner-in-Charge of the Portland Bureau of Emergency Management, the Commissioner-in-Charge of the Portland Bureau of Emergency Management or his or her designee, unless it would create a quorum of the City Council;
- C. D. Chief Administrative Officer;
- **D.** E. City Attorney;
- E. F. City Auditor;
- F.G. Director, Portland Bureau of Emergency Management;
- G.H. Chief of Portland Fire & Rescue;

- H.I. Chief of Portland Police Bureau;
- **LJ.** Director, Bureau of Emergency Communications;
- J.K. Administrator, Portland Water Bureau;
- K.L. Director, Bureau of Transportation;
- L.M. Director, Human Resources;
- M.N. Director, Bureau of Environmental Services.
- O. Director, Portland Parks and Recreation.
- P. Director, Bureau of Development Services.
- Q. Director, Portland Housing Bureau.
- **Q.** R. If the Mayor is unavailable to Chair the DPC, the duties shall be performed and authority exercised by the first of the City officials in the order of membership listed in Subsections A. MQ. above who is able and available.
- b. The amendments to Chapter 3.125.030 under this Ordinance shall be effective on and after September 1, 2014.
