I will want to flag the fact that, to my eye, this looks like a potential hit on the urban forest canopy that will have to be mitigated for and that urban forestry needs to be at the table. The canopy looks pretty mature to me and this appears to be one of those cases where mature trees will likely be lost with replacement with trees of caliper that will take years to actually replace.
