ORDINANCE No. 184851

Designate a parcel of City-owned property located at the intersection of SW Spring St and SW Vista Ave as public right-of-way and assign to the Bureau of Transportation (Ordinance)

The City of Portland ordains:

Section 1. The Council finds:

- 1. The City of Portland owns fee title to property at the intersection of SW Spring Street and SW Vista Avenue also referenced as 1S1E04CB tax lot 9100.
- 2. This parcel was acquired from Portland General Electric in Book 528, Page 832, recorded September 29, 1966 and is to be used for street or other public purposes.
- 3. The property is currently improved with a sidewalk and stairway from SW Spring Street to SW Vista Avenue but was never officially designated as right-of-way.
- 4. Street improvements are in the public interest and consistent with the City's policies; therefore, the property should be designated as public right-of-way.
- 5. There is minimal cost for staff time for transfer of this property to public right-of-way, likely not exceeding \$500.00. Funds are available in the Transportation Fund 9TR000000116, FY 2011-2012 budget.

NOW, THEREFORE, the Council directs:

- a. That the City-owned property described on Exhibit A and depicted on Exhibit B attached hereto, is hereby designated as public right-of-way and assigned to the Bureau of Transportation.
- b. That the Auditor shall return a certified copy of this Ordinance to the Right-of-Way Acquisition Section, Bureau of Transportation, for recording in the Multnomah County Deed Records. Right-of-Way Acquisition shall return the recorded Ordinance to the Auditor and retain a copy for its records in Right of Way File No. 9000-1.
