ORDINANCE No. 187961

*Amend previously adopted regulations to clarify calendar reporting requirements of the Regulation of Lobbying Entities and City Officials code (Ordinance; amend Ordinance No. 187854)

The City of Portland ordains:

Section 1. The Council finds:

- 1. On June 29th, 2016, City Council passed Ordinance 187854, which included amendments to the requirements for reporting calendar activity contained in City Code Subsection 2.12.070.D. Ordinance 187854 will be effective on September 1, 2016
- 2. It is necessary to add specificity to the categories of individuals required to be disclosed on public calendars in the amendments to Code Subsection 2.12.070.D contained in Ordinance 187854 to meet Council's intent.

NOW, THEREFORE, the Council directs:

- a) Amend Code Subsection 2.12.070.D.1, as adopted by Ordinance No. 187854, as follows:
 - D. City Elected officials and City directors shall post their calendars of activities that reflect official City business 15 days after the end of the calendar quarter for the previous calendar quarter, unless an elected official or City director determines that such posting poses a safety threat.
 - 1. Unless otherwise exempted, calendars required by this Section shall note the date and length of scheduled official business that includes other City <u>Elected Oofficials</u>, <u>City directors</u> or outside parties. Calendar items must list primary participants or organizations in attendance.

Section 2. The Council declares that an emergency exists because the amendments to Chapter 2.12 previously passed by Council will be in effect September 1, 2016; therefore, this ordinance shall be in full force and effect from and after its passage by Council.
