

ORDINANCE No. 183426

*Accept a grant in the amount of \$300,000 from Metro for the SmartTrips Green Line project (Ordinance)

The City of Portland ordains:

Section 1. The Council finds

1. The Bureau of Transportation applied to Metro for a grant in the amount of \$300,000 for the SmartTrips Green Line project on September 1, 2008 and
2. Metro has notified the City of Portland that it will award a grant for the SmartTrips Green Line project to the Bureau of Transportation in the amount of \$300,000.

NOW THEREFORE, The Council directs:

- a. The Mayor is hereby authorized to accept on behalf of the City of Portland a grant from Metro for the SmartTrips Green Line project in the amount of \$300,000.
- b. The FY 2009/2010 and 2010/11 budgets are hereby amended as follows:

GRANTS FUND

Fund 217001

Business Area – TR009

Bureau Program Expenses

- 2009/10 Budget
\$60,000 is to be appropriated to staff time
\$140,000 is to be appropriated to materials and services
- 2010/11 Budget
\$ 70,000 is to be appropriated to staff time
\$ 30,000 is to be appropriated to materials and services

Section 2. The Council declares that an emergency exists because a delay would unnecessarily delay the City's ability to perform the activities authorized by the grant; therefore, this Ordinance shall be in full force and effect from and after its passage by Council.
