

**ORDINANCE NO. 183438**

\* Amend contract with Technical Assistance for Community Services, Inc. for implementation of a One-Stop Domestic Violence Service Center (Ordinance, amend Contract No. 37428)

The City of Portland ordains:

Section 1. The Council finds:

1. The City required outside professional services to conduct a feasibility study for a One-Stop Domestic Violence Service Center which Technical Assistance for Community Services, Inc. agreed to provide these services Contract No. 38037 dated July 11, 2008.
2. To maintain continuity of the project, Technical Assistance for Community Services, Inc has agreed to provide additional services to implement the One-Stop Domestic Violence Service Center.
3. To continue Technical Assistance for Community Services, Inc work on this matter, it is necessary to increase the terms of the agreement by \$10,000.00 to a total amount of \$146,725.00.
4. Council authorized funds necessary to implement the One-Stop Domestic Violence Service Center in the FY2008-2009 Budget, and approved a carry-over of funds in the Fall 2009 BuMP process. .

NOW, THEREFORE, the Council directs:

- a. The Commissioner of Public Affairs is authorized to extend Contract No. 37428, dated July 11, 2007, to provide for representation by outside counsel in an additional amount of \$10,000.
- b. The scope of the agreement is amended to allow for implementation of the One-Stop Domestic Violence Service Center.
- c. If applicable, the provisions of City Code Chapter 5.68 are waived.
- d. The Mayor and Auditor are authorized to draw and deliver warrants in payment of legal services provided under this Legal Services Agreement.


