Apply for a grant from the State of Oregon Department of Environmental Quality for \$20,728 to allow Tabor Consulting Group to produce videos on waste prevention in home remodeling. (Ordinance)

The City of Portland ordains:

Section 1. The Council finds:

- 1. In April 2006, the City of Portland Council passed Resolution No. 36423 establishing goals for the solid waste and recycling system, including a 75% recycling rate by 2015.
- 2. Portland City Code, Section 17.102.270 requires businesses to recycle 75% of their waste and this grant to Tabor Consulting Group will help businesses meet that goal.
- 3. Tabor Consulting Group seeks to produce a series of videos on reducing waste in home remodeling. The short videos will illustrate specific activities to reduce the amount of material produced and disposed during residential remodeling. The videos will raise awareness and promote behavior change among average homeowners and professionals involved in remodeling.
- 4. The Department of Environmental Quality provides grants to local jurisdictions around the State. By law, the grants must go to local governments, but local governments may contract with community groups, private individuals, non-profit organizations, schools, businesses or chambers of commerce to implement grant-funded projects.
- 5. The City's Solid Waste and Recycling program will pass this grant, if awarded, to Tabor Consulting Group for this project.
- 6. No City match is required.

NOW, THEREFORE, the council directs:

- a. The Mayor is hereby authorized to make application to the Department of Environmental Quality for a grant in the amount of \$20,757.50.
- b. The Mayor is authorized to provide such information and assurances for the grant period.
