

ORDINANCE No. 183476

Amend contract with David Evans and Associates, Inc. for additional work and compensation for the Umatilla Pump Station Upgrade Project No. E08589 (Ordinance, amend Contract No. 36485)

The City of Portland ordains:

Section 1. The Council finds:

1. The Bureau of Environmental Services (BES) has need of continuing professional engineering services provided by David Evans and Associates, Inc. for the completion of design work for the Umatilla Pump Station Upgrade.
2. David Evans and Associates is providing professional engineering services under Contract No. 36485, effective March 6, 2006 with an expiration date of January 31, 2011.
3. Additional design services are required to appropriately address constructability issues that were identified during the BES review of the 100% plans and technical specifications.
4. The estimated cost of this contract amendment is \$33,750. Funds are available in the Sewer System Operating Fund, FY 2010 Budget, Bureau of Environmental Services, WBS Element E08589.D14.

NOW, THEREFORE, the council directs:

- a. The Commissioner of Public Affairs and Auditor are authorized to increase the contract amount of amended contract No. 36485 with David Evans and Associates, Inc., in a form substantially in accordance with the amendment attached as Exhibit A, for the purpose described in Section 1, in the amount of \$33,750.
- b. The Mayor and Auditor are hereby authorized to draw and deliver warrants chargeable to the Sewer System Operating Fund Budget when demand is presented and approved by the proper authority.
