ORDINANCE No. 183500

*Authorize contract with lowest responsive and responsible bidder for construction of Fire Station 31 for estimated cost of \$2,190,228 (Ordinance)

The City of Portland ordains:

Section 1. The Council finds:

- 1. On November 7, 1998 the citizens of Portland authorized the sale of general obligation bonds for a \$61.1 million program to improve City emergency services. Included in the bond was the construction of new fire stations.
- 2. Fire Station 31 is the final new fire station to be constructed. The site is currently occupied by the existing Fire Station 31 which will be razed to construct the new two-story station.
- 3. The 6,936 square foot station will house one company of firefighters and their vehicles and is designed to be expandable for two companies at a future date.
- 4. The construction of the Fire Station 31 is estimated to cost \$2,190,228. The construction estimate is within the program budget.
- 5. The design is complete and the construction documents are being prepared to go out to public bid.

NOW, THEREFORE, the Council directs:

- a. The Mayor and Auditor are hereby authorized to execute a contract with the lowest responsive and responsible bidder for the construction of Fire Station 31, in accordance with the plans and specifications to be filed with the Purchasing Agent.
- b. The Mayor and Auditor are hereby authorized to draw and deliver checks chargeable to the fiscal year 2010-2011 Fire and Rescue Facilities GO Bond Construction Fund budget when demand is presented and approved by the proper authorities.

SECTION 2. The Council declares that an emergency exists because a delay may result in additional expense, and will unnecessarily deprive the City of the benefits of completion of the contract at an early date; therefore this ordinance shall be in full force and effect from and after its passage by Council.
