ORDINANCE No. 183511

*Approve settlement of claims with Ken Leahy, Construction, Inc. (Ordinance)

The City of Portland ordains:

Section 1. The Council finds:

- 1. In December 2007, the City of Portland, Bureau of Environmental Services ("BES"), filed a lawsuit against Ken Leahy Construction, Inc., and Thomas/Wright, Inc., in Multnomah County Circuit Court, entitled *City of Portland v. Ken Leahy Construction, Inc., and Thomas/Wright, Inc.*, Case No. 0712-14686, asserting claims for breach of the contract and for negligence.
- 2. KLC has agreed to settle with BES as shown in the attached Exhibit 1 (Settlement Agreement with KLC). The City Attorney's office and BES recommend approval of this settlement by City Council.

NOW, THEREFORE, the Council directs:

a. The Director of BES is authorized to execute the Settlement Agreement with Ken Leahy Construction, Inc., in substantially similar form to that attached as Exhibit 1 to this Ordinance. Funds received pursuant to this ordinance shall be placed in BES's account.

Section 2. The Council declares that an emergency exists in order to avoid undue and costly delay in settling this lawsuit; therefore, this Ordinance shall be in full force and effect from and after its passage by the Council.
