

ORDINANCE NO. 183541

* Authorize application to the State Historic Preservation Office for a Historic Preservation Fund Grant of \$17,000 to support the City's historic resources program (Ordinance)

The City of Portland ordains:

Section 1. The Council finds:

1. The State Historic Preservation Office (SHPO) invited the City of Portland as a Certified Local Government to apply for a Historic Preservation Fund Grant.
2. The Historic Preservation section of the Bureau of Planning is requesting the Historic Resources Fund Grant. The grant will fund projects including survey work, preservation planning, and supplementing program funding for the City's historic resources program. Funds requested for this grant total \$17,000 for the period April 10, 2010 to August 31, 2011.
3. Local match in the amount of \$17,000 will be provided by funds from the Historic Preservation program, SAP cost center PNCP000002 for FY 2009-10 and FY 2010-11. The match will be in the form of salary, benefits and materials.

NOW THEREFORE, The Council directs:

- a. The Mayor is hereby authorized to make application to the State Historic Preservation Office for a grant in the amount of \$ 17,000, in a form substantially in accordance with the form attached as Exhibit A, SHPO Certified Local Government (CLG) Grant Application.
- b. The Mayor is authorized to provide such information and assurances as are required for the grant period.

Section 2. The Council declares that an emergency exists because the grant application must be submitted no later than February 26. Therefore this ordinance shall be in full force and effect from and after its passage by the Council.
