ORDINANCE No. 183594

*Authorize the Bureau of Environmental Services to amend legal descriptions for permanent and temporary easements and to acquire said easements for the construction of the Fanno Pump Station Pressure Line – Garden Home Section Replacement Project through the exercise of the City's Eminent Domain Authority. (Ordinance; amend Ordinance No. 183126)

The City of Portland ordains:

Section 1. The Council finds:

- 1. Ordinance No. 183126 passed City Council August 19, 2009 authorized the Bureau of Environmental Services to acquire permanent and temporary easements for construction of the Fanno Pump Station Pressure Line Garden Home Section Replacement Project through use of the City's Eminent Domain Authority.
- 2. As a result of a change in project design, it has been determined that a change is required to the Sewer Easement and Temporary Construction Easement areas needed on the property located at 7475 SW Oleson Road (also referenced as 1S124DB 01800).
- 3. Funds are available in the Sewer System Operating Fund, FY 2009-2010 Budget, Bureau of Environmental Services, WBS E08293.L65.

NOW, THEREFORE, the council directs:

- a. The Director of the Bureau of Environmental Services or designee and/or City Attorney are authorized to acquire the necessary permanent and temporary easements for the Fanno Pump Station Pressure Line Garden Home Section Replacement Project under the Eminent Domain Authority of the City, including filing an action to acquire the property interests described herein or negotiating just compensation with property owners within available project budget funds. The Director of the Bureau of Environmental Services or designee and/or City Attorney are further authorized to enter into obligations agreements with property owners to address construction management concerns within available project budget funds.
- b. The property affected by this ordinance is described on Exhibit A and depicted on Exhibit B attached hereto and by this reference made a part hereof.
- c. The cost incurred in connection with the acquisition herein authorized shall be charged to the Fanno Pump Station Pressure Line Garden Home Section Replacement Project, WBS E08293.
- d. All remaining portions of Ordinance No. 183126 shall remain unchanged and all conditions thereof shall remain in full force and effect.
- e. The Mayor and Auditor are hereby authorized to draw and deliver warrants chargeable to the Sewer System Operating Fund Budget when demand is presented and approved by the proper authority.
- Section 2. The Council declares that an emergency exists because all Fanno Basin flow is being diverted to Clean Water Services (CWS) resulting in significant costs to the City of Portland.

 Therefore, this ordinance shall be in full force and effect from and after its passage by the Council.
