ORDINANCE No. 183610

Authorize an Intergovernmental Agreement with Portland Public Schools, School District #1 to provide janitorial services for the locker room at Wilson Pool (Ordinance)

The City of Portland ordains:

Section 1. The Council finds:

- 1. Portland Parks & Recreation owns and operates Wilson Pool, a popular outdoor Southwest Portland aquatics facility. The pool, which is open from June through September, provides a variety of aquatic recreation opportunities including swim lessons, lap and leisure swim, diving, waterplay features, and slides.
- 2. Wilson Pool is located on Portland Public Schools property at Wilson High School. Portland Public Schools owns and maintains the locker rooms that are used by the pool customers.
- 3. Clean facilities are a key component of the Bureau's Customer Service Standards. Neat, well-stocked areas enhance the experience of the customer, and contribute to the quality of the visit. Portland Public Schools has provided these services through its janitorial workforce.
- 4. Portland Parks & Recreation and Portland Public Schools must establish an intergovernmental agreement retroactive to June 1, 2009 in order to facilitate payment for these services.

NOW, THEREFORE, The Council Directs:

a. The Director of Portland Parks & Recreation is hereby authorized to enter into an intergovernmental agreement with Portland Public Schools in a form substantially in accordance with the agreement attached as Exhibit A.
