

**ORDINANCE No. 183634**

- \* Accept a donation from Fireman's Fund Insurance Company in the amount of \$7,000.  
(Ordinance)

The City of Portland ordains:

Section 1. The Council finds:

1. Fireman's Fund Insurance Company will donate \$7,000 to be used towards purchasing of the FLIR (Forward Looking Infrared) System for use on the Portland Fire & Rescue (PF&R) Fireboat Williams.
2. The Fire Chief recommends that the Council accept the donation from Fireman's Fund Insurance Company.

NOW, THEREFORE, the Council directs:

- a. The City Council accepts the donation of \$7,000 to be used towards the purchase of the FLIR System and thanks Fireman's Fund Insurance Company for its donation.

Section 2. The Council declares that an emergency exists because it is important that this equipment be purchased as soon as possible; therefore, this ordinance shall be in force and effect from and after its passage by the Council.

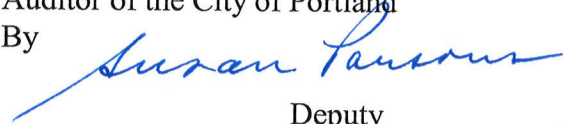
