## ORDINANCE No. 183687

\* Authorize an Intergovernmental Agreement with Multnomah County for partial costs related to the creation of a criminal justice information system network (Ordinance)

The City of Portland ordains:

## Section 1. The Council finds:

- 1. The City and the County have a mutual interest in and will benefit from the creation of a criminal justice information system (CJIS) network.
- 2. Multnomah County agreed to manage a feasibility study for the creation of a CJIS network throughout Multnomah County and to provide contract management.
- 3. The County entered into an agreement with MTG Management Consulting LLC for the CJIS feasibility study.
- 4. The City desires to reimburse the County for partial costs related to the CJIS network feasibility study in the amount of \$35,000 from existing Police Bureau appropriation.

## NOW, THEREFORE, the Council directs:

a. The Commissioner of Public Safety and Auditor are hereby authorized to enter into an agreement with Multnomah County substantially in accordance with the agreement attached as Exhibit A.

Section 2. The Council declares an emergency exists because delay in proceeding with this agreement will unnecessarily deprive the City and the County of the benefits of this agreement. Therefore, this ordinance shall be in full force and effect from and after its passage by the Council.
