ORDINANCE NO. 183689

*Amend contract with Shearer & Associates, Inc. to increase compensation, extend the performance period, and increase the scope of work for the Burlingame Tanks Improvements Project (Ordinance; amend Contract No. 30000960)

The City of Portland ordains:

Section 1. The Council finds:

- 1. The City of Portland Water Bureau entered into a contract with Shearer & Associates, Inc. for construction services on the Burlingame Tanks Improvements Project.
- 2. After work had started on the tanks, it was discovered that the roof and upper shell walls of Tank No. 4 were severely corroded, and the coal tar lining is failing. Exposed steel within the tank is also in need of recoating. Additional funding is required to pay for these new repairs.
- 3. The contract will be amended to increase the contract by \$371,543.22. The new contract total will be \$1,010,043.30. Funding is available in the FY 2009-10 Budget and has been requested in the FY 2010-11 Budget.

NOW, THEREFORE, the Council directs:

- a. That the Commissioner-in-Charge and Auditor are authorized to execute on behalf of the City a change order to Contract No. 30000960 with Shearer & Associates, Inc. as outlined in a form substantially in accordance with the change order attached as Exhibit A at a cost not to exceed \$371,543.22.
- b. The Mayor and Auditor are hereby authorized to draw and deliver checks chargeable to the Water Fund when demand is presented and approved by the proper authorities.

Section 2. The Council declares that an emergency exists because Burlingame Tank No. 4 is a critical part of the water system in the area it serves. The tank was not originally scheduled to be out of service for the length of time needed to replace the roof and must be back in service by the beginning of the peak demand season for the Water Bureau. If the tank is not placed back in service as quickly as possible, additional cost will be incurred due to contract delays and the pumping required to supply water to the area. Additionally, residents in the area may experience a loss of flow or pressure. Therefore this ordinance shall be in full force and effect from and after its passage by the Council.


