Authorize an Intergovernmental Agreement with Portland Public Schools, School District #1 to share the costs of additional design services to incorporate Washington High School into the Washington High School Community Center project (Ordinance).

The City of Portland ordains:

Section 1. The Council finds:

- 1. Portland Parks & Recreation (PP&R) conducted work in 2009/2010 to design a new Community Center on the PP&R owned property adjacent to Washington High School, located at SE Stark between SE 12th and 14th Aves.
- In 2009, PP&R secured a Federal Economic Development Planning Grant to begin design and public involvement processes. In April 2009, SERA Architects was selected through a RFP process to be the design consultant for the project. The first meeting of the advisory committee was also held in April. Early in the design process the Portland Public School District (PPS) and the public expressed a desire that the Washington High School Building be included as part of the community center design.
- 3. SERA Architects submitted a proposal for extra services to include in their design work a community center option that utilized space in the Washington High School Building. SERA submitted a proposal for \$29,189. PPS has agreed to pay for half the additional amount, or \$14,595. This IGA will formalize this agreement.

NOW, THEREFORE, The Council Directs:

The Director of Portland Parks & Recreation is hereby authorized to enter into an a. intergovernmental agreement with Portland Public Schools in a form substantially in accordance with the agreement attached as Exhibit A.
