*Amend Legal Services Agreement with Cascadia Law Group for outside counsel. (Ordinance; amend Contract No. 34620)

The City of Portland ordains:

Section 1. The Council finds:

- 1. The Bureau of Environmental Services required the services of outside legal counsel to provide legal advice and strategy regarding the Portland Harbor Superfund Site.
- 2. The law firm of Cascadia Law Group entered into Legal Services Agreement No. C34620 to provide these services as they relate to natural resources restoration, insurance and early clean-up issues.
- 3. It is necessary to increase the amount of the agreement to provide payment for such services and to continue work on this project.

NOW, THEREFORE, the Council directs:

- The City Attorney is authorized to extend Legal Service Agreement No. a. C34620, which provides representation by outside counsel, in an additional amount of \$500,000, bringing the total of this contract to \$2,075,000.
- b. If applicable, the provisions of City Code Chapter 5.68 are waived.
- The Mayor and Auditor are authorized to draw and deliver warrants in C. payment of legal services provided under this Legal Services Agreement chargeable to the appropriate Center Code.

Section 2. The Council declares that an emergency exists in order to pay for legal services necessary in the matter of the Portland Harbor Superfund Site; therefore, this ordinance shall be in full force and effect from and after its passage by the Council.
