ORDINANCE No. 183747

Authorize Intergovernmental Agreement with Oregon Department of Environmental Quality for funding of a Portland Harbor Stormwater Source Control Coordinator (Ordinance)

The City of Portland ordains:

Section 1. The Council finds:

- 1. The Council has designated the Bureau of Environmental Services (BES) as the City's lead representative on the Portland Harbor Superfund Site. BES is coordinating this work with multiple other City programs including the Office of Healthy Working Rivers.
- 2. An important part of the Superfund work is identifying sources of contamination to the Willamette River and its sediments and eliminating those sources to prevent future recontamination.
- 3. The City has been working closely with DEQ to develop a comprehensive stormwater management plan for Portland Harbor, and has been funding a DEQ Portland Harbor Stormwater Source Control Coordinator through an Intergovernmental Agreement. The purpose of the Intergovernmental Agreement is to provide DEQ with resources to evaluate and control stormwater discharged from Portland Harbor upland sites to the City stormwater conveyance system and the Willamette River. DEQ costs include personal services, services and supplies and DEQ indirect costs.
- 4. The Intergovernmental Agreement was initially executed in September 2004, effective through June 30, 2005 (Ordinance 178748). An amendment to extend the agreement was executed in June 2005 for one year, with the option of 3 additional one-year renewals (Ordinance 180181). Council authorization for this agreement will expire in June 2010.
- 5. The Bureau of Environmental Services recommends entering into a new agreement to continue funding for a 0.7 FTE DEQ Portland Harbor Stormwater Source Control Coordinator. The initial term of this agreement will be July 1, 2010 through June 30, 2011, with the option to renew annually for up to four additional years. The work and budget required in subsequent years will depend upon project needs.
- 6. The FY 2010-11 annual cost of this agreement is estimated to be about \$ 110,000. Funds are available in the Environmental Remediation Fund, FY 2010-11 Budget, Bureau of Environmental Services, Cost Center ESDR000004, Account No. 529000.

NOW, THEREFORE, the council directs:

a. The Director of the Bureau of Environmental Services is authorized to execute an Intergovernmental Agreement for the purpose described in Section 1, in a form substantially in accordance with Attachment A, in an amount not to exceed \$ 110,000, effective from July 1, 2010 to June 30, 2011.

- b. The Director is authorized to execute annual amendments renewing the Intergovernmental Agreement, as long as the annual amendment amount does not exceed the FY 2010-2011 Agreement budget by more than 25 percent.
- c. The Mayor and Auditor are hereby authorized to draw and deliver warrants chargeable to the Environmental Remediation Fund Budget when demand is presented and approved by the proper authority.
