* Accept two McKinney-Vento grants totaling \$513,060 from the U.S. Department of Housing and Urban Development for administration of the Homeless Management Information System and OTIS programs (Ordinance)

The City of Portland ordains:

Section 1. The Council finds

- 1. The Portland Housing Bureau (PHB) applied to the U.S. Department of Housing and Urban Development (HUD) on 11/24/2009 for annual renewal of two McKinney-Vento grants totaling \$513,060 to pay for the administration of the regional Homeless Management Information System HMIS and OTIS supportive housing programs.
- 2. HUD has notified the City of Portland that it will award an annual renewal grant for the administration of the regional Homeless Management Information System (HMIS) in the amount of \$241,074; and the OTIS supportive housing program in the amount of \$271,986.

NOW THEREFORE, The Council directs:

- a. The Mayor is hereby authorized to accept on behalf of the City of Portland two grants from HUD in the total amount of \$513,060 to administer the HMIS and OTIS programs and to execute grant agreements in substantially the form of the attached exhibit for this purpose.
- b. The OMF Grants Office is authorized to perform all administrative matters in relation to the grant application, grant agreement or amendments, requests for reimbursement from the grantor, and to submit required online grant documents on the Mayor's behalf.

Section 2. The Council declares that an emergency exists because a delay would unnecessarily delay the City's ability to perform the activities authorized by the grant; therefore, this ordinance shall be in full force and effect from and after its passage by the Council.
