* Accept a grant in the amount of \$20,000 from the Oregon Department of Transportation, Transportation Safety Division, Multi-Agency Traffic Team enforcement for officer overtime (Ordinance)

The City of Portland ordains:

Section 1. The Council finds:

- 1. The Police Bureau applied to the Oregon Department of Transportation for a grant in the amount of \$20,000 for Multi-Agency Traffic Team enforcement for Traffic Division Officer overtime; and
- 2. The Oregon Department of Transportation has notified the City of Portland that it will award a grant for the Multi-Agency Traffic Team enforcement to the Police Bureau in the amount of \$20,000; and
- 3. The grant period is February 1 through September 30, 2010; and
- 4. This grant requires \$5,000 in cash match, which will be funded with existing Police Bureau appropriation within the Police Bureau's Traffic Division.

NOW THEREFORE, The Council directs:

- a. The Mayor is hereby authorized to accept on behalf of the City of Portland a grant from the Oregon Department of Transportation for the Multi-Agency Traffic Team enforcement in the amount of \$20,000.
- b. The FY 2009/2010 budget is hereby amended as follows:

Bureau Program Expenses – \$2,500

c. The OMF Grants Office is authorized to perform all administrative matters in relation to the grant application, grant agreement or amendments, requests for reimbursement from the grantor, and to submit required online grant documents on the Mayor's behalf.

Section 2. The Council declares that an emergency exists because a delay would unnecessarily delay the City's ability to perform the activities authorized by the grant; therefore, this ordinance shall be in full force and effect from and after its passage by the Council.
