

ORDINANCE No. 183879

\* Authorize an Intergovernmental Agreement with Multnomah County for the use of funds from the Edward Byrne Memorial Justice Assistance Grant Program FY 2010 Local Solicitation (Ordinance)

The City of Portland ordains:

Section 1. The Council finds:

1. The U.S. Department of Justice (USDOJ), Office of Justice Programs (OJP), Bureau of Justice Assistance (BJA) will provide grant funding under the Edward Byrne Memorial JAG Program.
2. The grant application supports the purpose areas of law enforcement programs, prosecution programs, prevention and education programs and technology improvement programs.
3. The FY 2010 JAG funding allocations are as follows: City award of \$405,649, Gresham Police Department award of \$100,392 and Multnomah County award of \$318,723.
4. A condition of the grant program requires the City to serve as the grant award recipient and administrator for the three agencies. The City of Portland wishes to execute an Intergovernmental Agreement with Multnomah County to obligate agency roles and responsibilities.
5. The grant period is October 1, 2009, through September 30, 2013.

NOW, THEREFORE, the Council directs:

- a. The Mayor and City Auditor are hereby authorized to authorize this intergovernmental agreement substantially in accordance with the Agreement attached as Exhibit A.
- b. The OMF Grants Office is authorized to perform all administrative matters in relation to the grant application, grant agreement or amendments, requests for reimbursement from the grantor and to submit required online grant documents on the Mayor's behalf.

Section 2. The Council declares an emergency exists because delay in proceeding with this agreement may impact grant funding and compliance. Therefore, this ordinance shall be in full force and effect from and after its passage by the Council.
