

RESOLUTION No. 36786

Accept Conceptual Design Report for Portland-Milwaukie Light Rail Project and provide Jurisdictional Findings (Resolution)

WHEREAS, City Council adopted Resolution No. 36625 on July 17, 2008 specifying a new Locally Preferred Alternative for the South Corridor Phase II: Portland-Milwaukie Light Rail Project (Project); and

WHEREAS, with Resolution 36625, City Council adopted a list of project issues as "Exhibit C" and requested that the TriCounty Metropolitan Transportation District of Oregon (TriMet) prepare a Conceptual Design Report (CDR), in collaboration with the Portland Bureau of Transportation to be reviewed by the Portland Design Commission, Planning Commission, Portland Development Commission and City Council prior to completion of the preliminary engineering phase of the project; and

WHEREAS, TriMet released a public discussion draft of the CDR on February 18, 2010; and

WHEREAS, TriMet completed development of preliminary project plans, representing a 30% level of design on March 31, 2010; and

WHEREAS, numerous open houses and meetings with interested citizens have been held to solicit feedback on the CDR and the overall Project design; and

WHEREAS, the Portland Design Commission considered the CDR on April 1, 2010; and

WHEREAS, the Portland Planning Commission held a public hearing on the CDR on April 13, 2010; and

WHEREAS, the Portland Development Commission considered the CDR on April 14, 2010; and

WHEREAS, written comments on the CDR have been received from the Portland Planning Commission, the City's Pedestrian Advisory Committee and Bicycle Advisory Committee, and by the Oregon Department of Fish and Wildlife;

NOW, THEREFORE, BE IT RESOLVED, that the City of Portland accepts the Portland-Milwaukie Light Rail Project Conceptual Design Report Public Discussion Draft attached as Exhibit A; and

BE IT FURTHER RESOLVED, that the City Council requests that the CDR be amended to include the "Scorecard" attached as Exhibit B and "Jurisdictional Findings" attached as Exhibit C and that a final version of the CDR report be published; and

BE IT FURTHER RESOLVED, that the City Council requests that TriMet prepare a new CDR prior to completion of the final engineering phase of the Project; and

BE IT FURTHER RESOLVED, that the City Council requests that the new CDR explore and address the issues, concerns, and opportunities identified in the "Jurisdictional Findings" attached Exhibit C; and

BE IT FURTHER RESOLVED, that the new CDR is to be prepared in collaboration with the Portland Bureau of Transportation and reviewed by the Portland Design Commission, Planning Commission, Portland Development Commission and City Council prior to initiation of project construction.
