*Approve Agreement for Reimbursement with Mentor Oregon Brokerage Services for Senior Recreation Services (Ordinance)

The City of Portland ordains:

Section 1. The Council finds:

- 1. Portland Parks & Recreation offers Inclusion Services through its Special Recreation section to developmentally disabled citizens who have demonstrated a need for support for these services.
- 2. Federal Medicaid funding is provided to and administered by Mentor Oregon Brokerage Services, who serves as the fiscal agent on behalf of developmentally disabled individuals who contract with various agencies to receive a variety of services.
- 3. This agreement provides for reimbursement for senior recreation services for Medicaid-eligible clients by the Portland Parks & Recreation Senior Center Project.

NOW, THEREFORE, the Council directs:

That the Mayor and the Auditor are authorized to execute an Agreement on behalf of a. the City, substantially in the form of the agreement attached to this Ordinance, Inclusion In. Brokerage Services.

Section 2. The Council declares that an emergency exists in order to avoid further delay in the provision of reimbursement to Senior Recreation Services. Therefore, this Ordinance shall be in force and effect from and after its passage by Council.
