

**ORDINANCE No. 183936**

\*Authorize Intergovernmental Agreement with Multnomah County for reimbursement for Community Inclusion Services and Start-up/Special Projects for people with developmental disabilities (Ordinance)

The City of Portland ordains:

Section 1. The Council finds:

1. Portland Parks & Recreation offers Inclusion Services through its Special Recreation section to developmentally disabled citizens who have demonstrated a need for support for these services.
2. Funding is provided to and administered by Inclusion Multnomah County, who serves as the fiscal agent on behalf of developmentally disabled individuals who contract with various agencies to receive a variety of services.
3. This agreement provides for reimbursement for Employment and Community Inclusion Services by the Portland Parks & Recreation to individuals aged 18 or older with developmental disabilities, to improve the individual's productivity, independence, and integration in the community.

NOW, THEREFORE, the Council directs:

- a. That the Mayor and the Auditor are authorized to execute an Agreement on behalf of the City, substantially in the form of the agreement attached to this Ordinance.

Section 2. The Council declares that an emergency exists in order to avoid further delay in the provision of reimbursement to the Inclusion Services program. Therefore, this Ordinance shall be in force and effect from and after its passage by Council.
