## ORDINANCE No. 183947

\* Ratify a Letter of Agreement with AFSCME Local 189, and Tamara Palmer authorizing the settlement of a grievance regarding working out of classification. (Ordinance)

The City of Portland ordains:

Section 1. The Council finds:

- Ms. Tamara Palmer is a Water Bureau employee who asserted via the contractual grievance procedure that she was often designated as acting Lab Manager and other duties beyond her Senior Laboratory Analyst classification.
- 2. Article 11.3 of the Collective Bargaining Agreement between the parties states "when an employee is assigned to a higher classification, the employee's pay rate shall be the step within the higher classification range which represents at least a three percent (3%) increase over the employee's regular rate in his or her former classification . . . ."
- 3. David Shaff, Water Bureau Director, affirmed two instances of Ms. Palmer's out of classification work as the Acting Lab Manager and Environmental Program Manager. He granted her compensation of \$13,637.94 for these instances of work out of classification.
- 4. The City and AFSCME Local 189 have a mutual interest in settling this grievance.

NOW, THEREFORE, the Council directs:

a. The Letter of Agreement between the City and AFSCME Local 189 attached as Exhibit A is hereby ratified by the Council.

Section 2. The Council declares that an emergency exists in order that this compensation action may occur without delay; therefore, this ordinance shall be in full force and effect from after its passage by the Council.
