*Amend Intergovernmental Agreement with Multnomah County related to the SUN Service Coordinating Council. (Ordinance; amend Contract No. 30001262)

The City of Portland ordains:

Section 1. The Council finds that:

1. The City entered into Contract No. 30001262 on March 24, 2010 with Multnomah County to provide support for the staffing of the System's Coordinating Council.
2. The City and County wish to extend the Contract expiration date from June 30, 2010 to June 30, 2011.
3. The City wishes to increase the amount of the IGA by \$27,000 for a total contract amount of \$39,000. Multnomah County will receive an additional \$12,000 to cover the 4% cut in City Parks and Recreation SUN Community School pass through funding for FY 2010-11, and \$15,000 to enhance programming and/or services at high need SUN Community School high school sites.
4. The Amendment to the Intergovernmental Agreement between the City and Multnomah County is attached as Exhibit A.

NOW, THEREFORE, the Council directs:

- a. The Office of the Mayor is hereby authorized to amend the Intergovernmental Agreement with Multnomah County to extend the expiration date to June 30, 2011 and to increase the contract by an additional \$27,000 at a cost not to exceed \$39,000 in a form substantially in accordance with Exhibit A attached.
- b. The Mayor and Auditor are hereby authorized to draw and deliver warrants chargeable to the General Fund when demand is presented and approved by the proper authority.

Section 2. The Council declares that an emergency exists in order to avoid any delay in providing grant funding to the School Districts to expeditiously proceed with increasing their service capacities; therefore, this ordinance shall be in full force and effect from and after its passage by Council.
