ORDINANCE No. 183991

Authorize Intergovernmental Agreement with Portland State University for management of the South Park Blocks (Ordinance)

The City of Portland ordains:

Section 1. The Council finds:

- 1. The City is owner of certain property between SW Jackson Street and SW Market Street along SW Park Avenue, commonly referred to as the South Park Blocks and assigned to Portland Parks & Recreation (PPR). Portland State University (PSU) is located adjacent to the South Park Blocks.
- 2. The City and PSU have a long history of coordinated use and management of South Park Blocks, with said management benefiting the respective interests of the City and PSU.
- 3. Pursuant to this Intergovernmental Agreement, attached as Exhibit A, PSU will be responsible for routine maintenance and operations. PPR will be responsible for major maintenance and permitting of commercial events and vendors. This Agreement will not result in new expenses to the City, as it essentially formalizes the existing management framework.
- 4. It is in the best interest of both the City and PSU that the coordinated management activities be set out more formally in agreement form, with the agreement to supersede previous agreements and understandings between the Parties.

NOW, THEREFORE, The Council Directs:

a. The Commissioner in Charge of Parks is authorized to execute an Intergovernmental Agreement, substantially similar to the one attached hereto and as approved as to form by the City Attorney, with Portland State University for their continued management of the South Park Blocks.
