

ORDINANCE NO. 183996

* Apply for a \$310,000 grant from the U.S. Department of Justice, Office of Justice Programs, Bureau of Justice Assistance FY 2010 Grant Program for the Gang Resistance Education and Training Program Regional Training Centers (Ordinance)

The City of Portland ordains:

Section 1. The Council finds:

1. The U.S. Department of Justice (USDOJ), Office of Justice Programs (OJP), Bureau of Justice Assistance (BJA) has invited the City of Portland to submit a new funding request for the Fiscal Year (FY) 2010 Gang Resistance Education and Training (G.R.E.A.T.) Western Regional Training Center, which is comprised of Alaska, California, Hawaii, Idaho, Montana, North Dakota, Oregon, South Dakota, Nebraska, Washington and Wyoming.
2. The City of Portland, Oregon Police Bureau wishes to apply for \$310,000 in grant funding, which would allow for the administration of the G.R.E.A.T. Western Regional Training Center for 12 months.
3. The USDOJ will reimburse the City a maximum of \$296,000 to fund base program expenses, including two FTEs (Regional Administrator and the Assistant Regional Administrator), travel, supplies and intra-agency expenses required to operate the G.R.E.A.T. Regional program as well as \$14,000 for start-up supplies to support new G.R.E.A.T. projects in the region. The grant period is October 1, 2010 through September 30, 2011.
4. This grant does not require a match.

NOW THEREFORE, The Council directs:

- a. The Mayor is hereby authorized to make application to the U.S. Department of Justice, Office of Justice Programs, Bureau of Justice Assistance for a grant in the amount of \$310,000.
- b. The Mayor is authorized to provide such information and assurances as are required for the grant period.
- c. The OMF Grants Office is authorized to perform all administrative matters in relation to the grant application, grant agreement or amendments, requests for reimbursement from the grantor and to submit required online grant documents on the Mayor's behalf.

Section 2. The Council declares that an emergency exists because delay in proceeding with this application may result in not receiving funding. Therefore, this ordinance shall be in full force and effect from and after its passage by the Council.


