

RESOLUTION No. 36811

Authorize Memorandum of Understanding with Oregon Department of Forestry and the City of Portland for qualified City personnel to participate in ODF Incident Management Team Shadow Program (Resolution)

WHEREAS, The purpose of the MOU (Exhibit A) is to describe Oregon Department of Forestry's (ODF) forest fire Incident Management Team "Shadow" Program, outline the process for City of Portland personnel to participate in the program and define ODF and City of Portland's commitments and understandings related to program management; and

WHEREAS, ODF's Incident Management Team consist of highly trained and experienced personnel that can provide an experiential learning opportunity to qualified Portland personnel, enhancing Portland's emergency response capability; and

WHEREAS, The ODF IMT Shadow Program permits City of Portland personnel who have been trained to at least the ICS 200 level and have current incident management responsibilities to shadow the ODF IMT for a period of up to five days; and

WHEREAS, The City of Portland will designate a primary point of contact to facilitate the shadow program activities on behalf of ODF, receive mobilization notices and coordinate efforts to fill shadow positions; and

WHEREAS City of Portland personnel will remain employees of their respective bureaus and subject to bureau policies and be required to have management approval for participation.

NOW, THEREFORE, BE IT RESOLVED, that the Portland City Council authorizes the Memorandum of Understanding as executed by the Oregon Department of Forestry and the City of Portland through the Portland Office of Emergency Management.

BE IT FURTHER RESOLVED, that the City of Portland will review this MOU every five years beginning the date of its initial adoption by ODF and the City.
