

ORDINANCE No. 184138

* Amend the Intergovernmental Agreement with Multnomah County for the support of the Gateway Center for Domestic Violence Services (Ordinance; amend Contract No. 30000956)

The City of Portland ordains:

Section 1. The Council finds:

1. On October 21, 2009 in Ordinance No. 183257 the City Council approved an Intergovernmental Agreement (IGA) with Multnomah County for the operation of a one-stop domestic violence services center, known as the Gateway Center for Domestic Violence Services (Gateway Center).
2. Since the IGA was entered into, the County has agreed to provide additional services to the center, specifically a Multnomah County Sheriff's Office Facility Security Officer (FSO). The FSO will provide the primary day-to-day security for the Gateway Center and will work closely with Portland Police Bureau personnel as needed.
3. In addition, amendments to the IGA include changing the title of the County's liaison to the Center, Jeff Cogen. At the time the IGA was entered into, Mr. Cogen was a Multnomah County Commissioner and has recently been elected as Multnomah County Chair.

NOW, THEREFORE, the Council directs:

- a. The Commissioner of Public Affairs is hereby authorized to enter into an amended agreement with Multnomah County to support the Gateway Center for Domestic Violence Services in a form substantially in accordance with Exhibit A.

Section 2. The Council declares an emergency exists because delay in proceeding with this agreement may unnecessarily delay the provision of services at the center; therefore this ordinance shall be in full force and effect after its passage by Council.
