

## ORDINANCE No. 184177

\* Authorize an Intergovernmental Agreement with Multnomah County not to exceed \$671,000 for chemical substance abuse treatment services to chronic offenders and for District Attorney and Parole and Probation services for chronic arrestees (Ordinance)

The City of Portland ordains:

Section 1. The Council finds:

1. The chronic recurrence of crime diminishes neighborhood livability and negatively impacts the community's perception of safety.
2. There is a causal relationship between substance abuse and the commission of crime.
3. If housing and treatment programs were more available for those offenders with the greatest need for and potential to benefit from treatment, a decrease in related crimes could be anticipated.
4. It is most cost effective to purchase residential treatment beds with non-profit organizations through an arrangement with Multnomah County; since these contracts and mechanisms for monitoring services already exists.
5. The Service Coordination Team is a working group which includes the Police and other City bureaus and Multnomah County agencies. The Service Coordination Team provides direction for the efforts undertaken in this project.
6. Multnomah County will manage a contract with Volunteers of America to provide outpatient drug and alcohol treatment for up to thirty males daily identified by a member of the Service Coordination Team.
7. Multnomah County will manage a contract with Volunteers of America to provide supportive housing and outpatient drug and alcohol treatment for up to twelve males daily identified by a member of the Service Coordination Team. Housing may be provided through an agreement between Volunteers of America and the Salvation Army.
8. Multnomah County will hire a Parole and Probation Officer who will have a reduced caseload and the ability to provide supervision for a limited number of individuals identified as on the Chronic Arrestee list.
9. Multnomah County will hire a Deputy District Attorney and clerical staff responsible for issuing and prosecuting drug offenses and related cases of those individuals who meet the chronic offender criterion.

NOW, THEREFORE, the Council directs:

a. The Mayor and City Auditor are hereby authorized to enter into an agreement with Multnomah County substantially in accordance with the agreement attached as Exhibit A at a cost not to exceed \$671,000.

Section 2. The Council declares an emergency exists because delay in proceeding with this agreement will unnecessarily deprive Multnomah County and the City of the mutual benefits of this agreement. Therefore, this ordinance shall be in full force and effect from and after its passage by the Council.
