

ORDINANCE No. 184221

* Accept a grant in the amount of \$94,215 from Oregon Department of Transportation for the Springwater Corridor Trail McLoughlin Bridge Staircase (Ordinance).

The City of Portland ordains:

Section 1. The Council finds

1. Portland Parks & Recreation (Parks) applied to Oregon Department of Transportation (ODOT) for a grant in the amount of \$94,215 for the Springwater Corridor Trail McLoughlin Bridge Staircase on 3-10-10.
2. ODOT has notified the City of Portland that it will award a grant for the Springwater Corridor Trail McLoughlin Bridge Staircase to Parks in the amount of \$94,215;
3. The deadline for completing the preliminary design of the project is December 31, 2010.

NOW THEREFORE, The Council directs:

- a. The Mayor is hereby authorized to accept on behalf of the City of Portland a grant from the Oregon Department of Transportation for the Springwater Corridor Trail McLoughlin Bridge Staircase in the amount of \$94,215 and to execute an intergovernmental agreement in substantially the form of the attached exhibit for this purpose.

- b. The FY 2010/2011 budget is hereby amended as follows:

GRANTS FUND

Fund 217001

Business Area – PK00

Bureau Program Expenses– \$94,215

- c. The OMF Grants Office is authorized to perform all administrative matters in relation to the grant application, grant agreement or amendments, requests for reimbursement from the grantor, and to submit required online grant documents on the Mayor's behalf.

Section 2. The Council declares that an emergency exists because a delay would unnecessarily delay the City's ability to perform the activities authorized by the grant. Therefore, this Ordinance shall be in force and effect from and after its passage by Council.
