Approve the designation of eight trees as Portland Heritage Trees (Ordinance)

The City of Portland ordains:

Section 1. The Council finds:

- 1. Section 20.40.150 of the City Code provides for the listing, designation and maintenance of Heritage Trees within the City which, because of their age, size, type, historical association or horticultural value, are of special importance to the City.
- 2. The Heritage Tree Committee has inspected and evaluated eight significant Portland area trees recently nominated for inclusion in the Heritage Tree program. The Committee has presented its findings to Portland's Urban Forestry Commission, a volunteer body with varying backgrounds on tree care issues. The Urban Forestry Commission recommends that Council designate the eight trees as Heritage Trees.

NOW, THEREFORE, The Council Directs:

- a. Under the provisions of PCC 20.40.150, the following eight trees are designated as Heritage Trees and are included in Portland's Heritage Tree Program:
 - Northern red oak (*Quercus rubra*) located on private property at 4706 SE 58th Street, and
 - 2) London plane tree (*Platanus X acerifolia*) located in City Right of Way adjacent to 2437 NE Regents Drive, and
 - 3) Sycamore maple (*Acer pseudoplatanus*) located in City Right of Way adjacent to 2923 NE 8th Street, and
 - 4) Loblolly pine (*Pinus taeda*) located on private property at 3045 NE 9th Avenue, and
 - 5) Burr oak (*Quercus macrocarpa*) located in City Right of Way adjacent to 2921-2955 SE Washington Street, and
 - 6) Southern catalpa (*Catalpa bignonioides*) located on private property at 3401 SE Clinton Street, and
 - 7) Deodar cedar (*Cedrus deodara*) located on private property at 3735 SE Woodstock Street, and

8) Coastal redwood (*Sequoia sempervirens*) located on private property at 7617 SE Main Street, and


